The Duties of the Officers or Appointees

The Secretary shall keep a journal (minutes) of the proceedings of the Board which shall indicate in summary statements all matters presented by the President of the University, the Secretary, the Treasurer, or other officer, or communi1 any source whatever, other than in cases by law required to be paid to the State Treasurer. The Treasurer shall keep the accounts of the moneys in his custody in such separate funds as shall be indicated by the Board of Regents or as are desirable and necessary for the proper and syste-
