4b. TRANSFER OF REAL PROPERTY LOCATED AT 5276 TEXAS AVENUE, RENO, NEVADA, DRI FOR POSSIBLE ACTION

4c. APPOINTMENTS TO FILL VACANCIES ON THE UNIVERSITY OF NEVADA, LAS VEGAS CAMPUS IMPROVEMENT AUTHORITY BOARD FOR POSSIBLE ACTION

Pursuant to legislation contained in AB 335 (Chapter 507, Statutes of Nevada 2013) as amended by AB 451 (Chapter 360, Statutes of Nevada 2015) the Board of Regents is authorized to appoint four members to the Board of Directors of the University of Nevada, Las Vegas Campus Improvement Authority (the "Authority"). One of the appointees must be either a member of the Board of Regents or an officer of the University and the other appointees must be members of the Board of Regents. Regents Cedric Crear and Kevin J. Page are current members of the Authority's Board of Directors. The Board Officers request approval of the appointment of Regent Trevor Hayes and Regent John T. Moran to fill vacancies on the Authority's Board of Directors replacing former Regents James Dean Leavitt and Michael B. Wixom.
